USE OF EXTERNAL ADVISERS FOR SENIOR DENTAL APPOINTMENTS IN THE PUBLIC DENTAL SERVICE

This updates the previous CDO letter on external advisers issued on 29 July 2011.

NHS Health Boards are reminded that when appointing to any senior non-specialist post in the Public Dental Service they should involve an External Advisor from the attached list.

The Scottish Government Directorates of Health and Social Care firmly recommends the inclusion of a trained External Advisor as it helps to ensure that the clinical quality of appointed candidates is maintained. The External Adviser will have relevant experience of the post, will have been trained in selection procedures and, being from a different board in the recruitment process, can provide advice on the appointment from a different perspective than the local clinical team. They can support the recruiting Board at each stage of the process, including advising on the job description, person specification, the selection methodology as well as being a member of a selection Panel. The function of the External Advisor is to advise the Panel on whether candidates meet the selection criteria i.e. that they are or are not appointable. The appointment decision however rests with the employing Authority.
