Introduction

Following publication of the CPI Checklist v3 on 1 January 2017, stakeholder feedback received by the Scottish Dental Clinical Effectiveness Programme (SDCEP), Dental Practice Advisors, territorial Health Boards and the Office of the Chief Dental Officer was recorded and collated by SDCEP's CPI team¹. In addition to collating the feedback, SDCEP's CPI team sourced supporting information, including details of available guidance, legislation, policy and/or regulatory requirements, for each individual item of feedback.

All feedback was considered by the CPI Working Group² at its 2019 meeting in Edinburgh. Following this meeting SDCEP's CPI team revised the checklist as agreed.
