## REVISED SCOTTISH DENTAL ACCESS INITIATIVE

### AMENDMENT NO. 166 TO THE STATEMENT OF DENTAL REMUNERATION

#### Summary

1. This circular advises of Amendment No. 166 to the Statement of Dental Remuneration (SDR) which updates Determination XIII – Recruitment and Retention Allowances (R&R), in conjunction with a non-SDR coordinating change to the Scottish Dental Access Initiative (SDAI).

**Scottish Dental Access Initiative (SDAI)**

1. The purpose of this Memorandum is to advise of the revised eligible areas to the Scottish Dental Access Initiative and Recruitment and Retention Allowance.
2. The SDAI offers financial assistance to establish a new, or expand or purchase an existing, NHS dental practice in areas where access to GDS availability is poor, i.e. unmet patient demand. We have recently reviewed with NHS Boards the areas which should be included as part of the SDAI grant, and from 10 March 2025, the areas where the grant is eligible are:
  - Dalmellington and Patna within NHS Ayrshire and Arran;
  - NHS Borders;
  - NHS Dumfries and Galloway;
  - Dunfermline, Glenrothes and Kirkcaldy within NHS Fife;
  - Stirlingshire within NHS Forth Valley;
  - Banff, Buchan, Fraserburgh and Moray within NHS Grampian;
  - Inverclyde within NHS Greater Glasgow and Clyde;
  - NHS Highland;
  - NHS Orkney;
  - NHS Shetland;
  - Arbroath, Forfar, Montrose, Perth and Kinross (excluding Perth City and Kinross) within NHS Tayside and;
  - NHS Western Isles.

  - Dunfermline, Glenrothes and Kirkcaldy within NHS Fife;
  - Stirlingshire within NHS Forth Valley;
  - Banff, Buchan, Fraserburgh and Moray within NHS Grampian;
  - Inverclyde within NHS Greater Glasgow and Clyde;
  - NHS Highland;
  - NHS Orkney;

- NHS Shetland;
- Arbroath, Forfar, Montrose, Perth and Kinross (excluding Perth City and Kinross) within NHS Tayside and;
- NHS Western Isles.
